Sir/Madam,

This has reference to your online application bearing registration no EX-01180-1819 on the above subject. In this regard, the following deficiencies / requirements have been observed during the scrutiny of the Inspection Report (Periodical Inspection conducted on 03.01.2019). The School is required to submit the specific compliance of the following deficiencies / requirements within 30 days:-

1. The School is required to submit Recognition Certificate as per the Section 18 of Right to Education Act, 2009 from the concerned State Government.
2. The school is required to submit copy of renewed certificates (as per formats (appendix) given in Affiliation Bye-Laws of the Board) of Health-Sanitation and safe drinking water duly issued from concerned/competent authority of the State Government.
3. 13 teachers are short & 03 teachers are untrained whereas the school is required to appoint all the teachers (on permanent basis instead of adhoc) who are trained and qualified as per provisions of Affiliation Bye-Laws of the Board to maintain section teacher ratio i.e. 1.5 teachers per section at each level.
4. ✓ The school is required to give clarification on area of campus in online form it was mentioned as 9347 sq. mtrs. and as per land certificate as well as IC informed that it was 8671 sq. mtrs.
5. The school is required to submit latest EPF challan in r/o of all employees.
6. The school is required to maintain FDR of reserve fund in the joint names of the Principal of the school and Managing Trustee/Member of the Society/trust/Company etc. running the school according to the strength of the students/norms of the Affiliation Bye-Laws of the Board and submit a copy of the same.
7. The number of sections of the school shall be restricted to 28 as per the number of class rooms reported by the Inspection Committee & other norms of Affiliation Bye Laws & shall not be increased by the school without approval of the Board.
8. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity related to running of school affiliated to CBSE. The school shall also be liable to bear all legal charges incurred by the Board. If any, arising out of these circumstances.

Keeping in view, the academic interest of the students, I am directed to convey approval of the competent authority for provisional extension of affiliation upto 31.03.2020 alongwith permission for registration of bonafide candidates of class IX and submission of list of existing candidates of the School for class X for current session.

However regularization of affiliation from 01.04.2017 for a period of 05 years will be subject to the specific compliance of the discrepancies communicated by the School within 30 days failing which the process of withdrawal of affiliation of the School may also be initiated.
